## **Volunteer Release and Waiver of Liability Form**

This Release and Waiver of Liability (the "release") executed on (date)

releases The Mobile Society for the Prevention of Cruelty to Animals (MSPCA), a non-profit corporation organized and existing under the laws of the State of Alabama and each of its directors, officers, employees and agents. The Volunteer desires to provide volunteer services for MSPCA and engage in activities related to serving as a volunteer.
Volunteer understands that the scope of Volunteer's relationship with MSPCA is limited to a volunteer position and that no compensation is expected in return for services provided by Volunteer; that MSPCA will not provide any benefits traditionally associated with employment to Volunteer; and that Volunteer is responsible for his/her own insurance coverage in the event of personal injury or illness as a result of Volunteer's services to MSPCA.
1. Waiver and Release: I, the Volunteer, release and forever discharge and hold harmless MSPCA and its successors and assigns from any and all liability, claims and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from the services I provide to MSPCA. I understand and acknowledge that this Release discharges MSPCA from any liability or claim that I may have against MSPCA with respect to bodily injury, personal injury, illness, death or property damage that may result from the services I provide to MSPCA or occurring while I am providing volunteer services.
2. <b>Insurance:</b> Further I understand that MSPCA does not assume any responsibility for or obligation to provide me with financial or other assistance, ncluding but not limited to medical, health or disability benefits or insurance of any nature in the event of my injury, illness, death or damage to my property. I expressly waive any such claim for compensation or liability on the part of MSPCA beyond what may be offered freely by MSPCA in the event of such injury or medical expenses incurred by me.
3. <b>Medical Treatment:</b> I hereby Release and forever discharge MSPCA from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with MSPCA.
4. <b>Assumption of Risk:</b> I understand that the service I provide to MSPCA may include activities that may be hazardous to me including, but not imited to, bites, scratches, slips, trips, falls, ringworm, parasites, zoonotic illness, lifting injuries, loss of personal property, damage to apparel or personal property or exposure to cleaners, involving inherently dangerous activities. As a volunteer, I hereby expressly assume the risk of injury or harm from these activities and Release MSPCA from all liability for injury, illness, death or property damage resulting from the services I provide as a volunteer or occurring while I am providing volunteer services.
5. <b>PetSmart:</b> I hereby agree that I am providing volunteer services to MSPCA assisting in pet adoptions or cat cleaning. This may also include assisting in adoptions of pets or cat cleaning through MSPCA at local PetSmart stores. I understand that neither MSPCA nor PetSmart is responsible for any illness or injury caused by any animals that I come into contact with during my volunteer work. I agree to hold harmless and release from liability MSPCA and PetSmart should I become sick or injured from any animals as a result of my volunteer work.
6. Photographic Release: I grant and convey to MSPCA all right, title and interests in any and all photographs, images, video or audio recordings of me or my children or my likeness or voice made by MSPCA in connection with my providing volunteer services to MSPCA.
7. <b>Other:</b> As a volunteer, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Alabama and that this Release shall be governed by and interpreted in accordance with the laws of the State of Alabama. I agree that in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of the Release shall not be affected.
