

From Lutsen/Tofte/Schroeder, take Highway 61 north into Grand Marais. On the far side of town you will see an IGA on your left and a Subway on your right. Just past these 2 landmarks you will come to the entrance to the Gunflint Trail (Cook County 12): turn left. Proceed uphill thru 1 intersection, past 1 gravel road on your right to the Cornerstone Baptist Church (Cedar Grove Ln.): turn right. Stay to your right and you will see the stable sign up ahead. Please park on the blacktop near the stable.

From Croftville/Grand Portage/Canada, take Highway 61 south <u>just</u> into Grand Marais. On your right you will see a large sign for Grand Marais made with a cairn and the entrance to the Gunflint Trail (Cook County 12): turn right. Proceed uphill thru 1 intersection, past 1 gravel road on your right to the Cornerstone Baptist Church (Cedar Grove Ln.): turn right. Stay to your right and you will see the stable sign up ahead. Please park on the blacktop near the stable.
