

Affidavit of Pennsylvania Residency and/or Affidavit Pertaining to Social Security Number

This is a multiuse affidavit form designed to assist Pennsylvania fishing license buyers with establishing Pennsylvania residency and for documenting that a buyer does not have a social security number due to certain reasons.

Affidavit of Residency - A *bona fide resident* of the Commonwealth of Pennsylvania is a permanent resident of this state who has a fixed intent to return to the Commonwealth when he leaves it and who maintains a permanent place of abode in Pennsylvania. An individual may not claim to be a bona fide resident of this Commonwealth for the purpose of obtaining a license while claiming residence in another state for any purpose.

This form may be used to provide proof of Pennsylvania residency when the license applicant does not possess or is not able to produce one of the following documents:

- 1. Valid Pennsylvania Driver's License
- 2. Valid Pennsylvania Non-driver Photo Identification Card
- 3. Current Pennsylvania Firearms Permit
- 4. Previous year's Pennsylvania State Income Tax Return showing proof of payment of personal income tax as a resident of Pennsylvania
- Previous year's Local Earned Income Tax Return showing tax paid to a Pennsylvania Municipality
- 6. Current Pennsylvania Voter's Registration Card

Affidavit Pertaining to Social Security Number – Designed for license buyers (such as the Amish and non-United States citizens) who do not have a social security number or who wishes to provide an alternative identifier number.
